



Hate Incident Monitoring Form

Introduction.

1. Please use this form to tell us about a **hate incident**.

A **hate incident** is something bad that happened to someone because they are different.

It could be something that happens to you or someone else.

It could be because the person is a different age or because the person is disabled.

It could be because the person is a different colour or comes from a different county. Or because they are different in another way.

2. No-one should have to put up with a **hate incident**.

Hate incidents are wrong, telling us makes a difference, if we don't know about it we can't change things.

3. Did the bad thing (**the hate incident**) happen to you?
- This means you are the victim.

Did you see or hear a bad thing happen to someone else?
- This means you are a witness.

Did someone tell you about the bad thing?

- This means you are a third party

This will help us to know if we can use the information you give. If you don't answer the questions in Section 7, we can't use the information you put on this form.

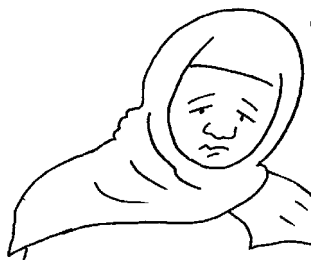
There are some questions that will give us really important information.

Data Protection.



There are 2 questions that the law says we have to ask you.

This part of the form helps us make sure we look after the information you have given us properly.

Please answer both questions so we know if we can use the information for the “Hate Incident Monitoring Project”. It will also help us know if we can share the information with anyone else.

Information from this form will be used to help us stop **hate incidents** in Leicestershire.

Because some of the information is personal we have to ask if it OK for us to use it, or to share it with other organisations like the Police.

The law says we always have to ask if it is OK for us to use personal information, or for us to share it.

If the information is not about you, we can not use it or share it unless the person says it's OK. The only time we might be able to use the information, or share it, even if the person has not said it is OK, is when we have to do something to keep the person safe. If we are able to contact the person to ask if it is OK to use the information, or to share it, we will ask them.
