Self Advocate Feedback

What stops you joining in and getting involved in the co-production meetings?

- Transport
- Making sure that you get there on time, taxi's often late.
- People with learning disabilities need lots of time to understand. Do not rush us.
- Being too busy. Meetings clash with other things you have planned.
- Might not be able to join in the conversation because you don't understand what is being talked about. Talking to fast.
- A lack of understanding from other people about involving people with learning disabilities.
- Lack of confidence.
- Is it time banking?
- Getting enough notice that the meeting is happening.
- Do you use red and yellow cards? Do you have work police? This makes it easier for us to join in.

Should meeting for people with learning disabilities be separated?

• Some people thought it maybe a good idea to help people have the time to understand. Co-production is a very difficult to understand.

Other ideas

- A group of which could check 'easy read' documents and help write guidelines of how to support people.
- Ask Claire to come and visit the locality groups to talk about co-production. It is a difficult thing to understand. It would be good for Claire to find other examples of what it is to help people understand. Can Claire find more examples which are local?
- The group though of thing which they thought were co-production, like health walk group, evening meal at the village hall, helping to make community gardens look nice.

Parents and Professional Feedback

What stops you joining in and getting involved in the co-production meetings?

- Plans are too big. Need to focus on small changes which will be easier to make a difference.
- Being asked the same questions at meetings, can we get together as one voice?
- Tick box exercise involvement prove that personal input is valued and you can make a difference.
- Not long enough time short deadlines.
- Wrong people being involved and writing plans for us.
- Plans are being written by staff before you consultation. Comments do not then get added to plan.
- Lack of confidence
- Transport costs and distance
- Getting enough notice about the meetings.
- Too many things you need to do to join in, like having police checks, forms to fill in to get travel expensive.
- Too much paper work

Should meeting for people with learning disabilities be separated?

- We should be asking people with learning disabilities this question.
- We should have opportunities for carers to say how they feel what's working and what's not working.
- What value will be added if you have separate meetings? How will it be of value?
- Need to have a balance to ensure value of any meeting respect for all
- Realistic expectations.
- Think about mixing with peers regardless of learning disabilities.
- You need to put together some principles together around meetings and co-production in easy read.

- You can tailor you meeting to different meetings
- Can set a pace where people can understand
- Meetings tend to be shorter
- The Partnership Board is an example where we have worked together as one group and meet separate in smaller groups for tasks. We think this works.
