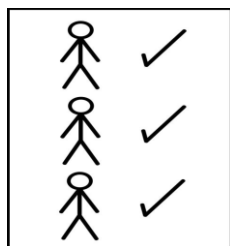

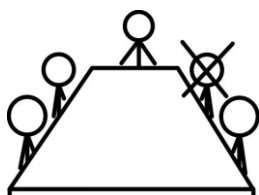

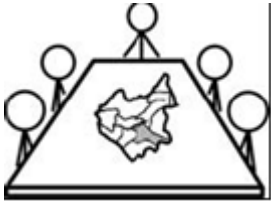
3. Actions from the last meeting

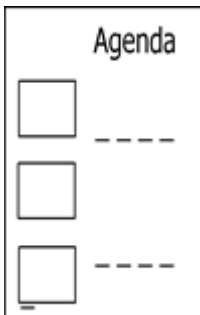

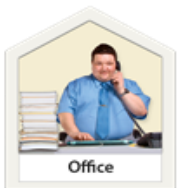
Better Lives Website
